

SECURITY SURCHARGE

VIA ALL: FROM HONG KONG SAR WORLDWIDE: HKD 20 FOR EACH DEPARTURE

EXCEPTIONS:

The security service charge will not apply to:

- Infants.

- Passengers transferring / transitting Hong Kong SAR.
- Passengers travelling on Industry / Agency Discount (ID/AD) tickets.
- Passengers holding diplomatic passports.

VIA AA:

- 1 A security surcharge will be assessed on any fare paying passenger each time travel involves enplanement on an AA transatlantic, transpacific or western hemisphere flight or a departure from Hong Kong SAR as shown below
- 2 For passengers travelling via AA in both directions, the security surcharge outlined below shall be applied twice except as noted.
- 3 The surcharge may be converted to the applicable currency for the country of origin in accordance with the appropriate IROE
 - a transatlantic travel to/from/via USA: USD 8 OW / 16 RT
 - Exception: from UK: GBP 6
 - b transatlantic travel to/from/via Canada: USD 8 OW / 16 RT
 - c transpacific travel to/from/via USA: USD 5 OW / 10 RT
 - d between USA and Central America / South America / Mexico (except for travel originating in Belize): USD 5 OW / 10 RT
 - e between Central America / South America / Mexico and Area 1 (except USA/Canada/ travel originating in Grand Cayman and in Belize): USD 5 OW / 10 RT
 - f for travel within Area 1:
 - USA to Caribbean: USD 7.50 OW /15 RT
 - Canada to Mexico / Caribbean / South America / Central America (except Grand Cayman): CAD 7 OW / 14 RT
 - Caribbean to USA: USD 7.50 OW / 15 RT
 - Caribbean / Costa Rica / Guatemala / El Salvador / Nicaragua / Honduras / Panama (except Curacao / Dominican Republic / Grand Cayman / Grenada / Trinidad and Tobago) to Area 1: USD 5 OW / 10 RT
 - between Grand Cayman and Area 1: USD 7.50 OW / 15 RT
 - g surcharge worldwide:
 - Belize to worldwide: no charge
 - Hong Kong to worldwide: HKD 20 (each departure)
 - Exemptions: infants and passengers transferring/transiting HKG, travelling on ID/AD tickets, holding diplomatic passports
 - h in addition to the above, to/from Costa Rica the local security charge will be USD 1 OW / 2 RT
 - *i in addition to the above, on flights from Jamaica worldwide the local security charge will be USD 1.20 OW*
 - *j in addition to the above, on flights from SXM worldwide the local security charge will be USD 1.55 OW*
 - k in addition to the above, a local security charge of USD 1.11 will apply on all departing



flights from UVF/SLU airports

VIA AC:

From Jamaica worldwide: USD 5 OW / CAD 6 OW

VIA AR:

From USA To South America: USD 5 OW / USD 10 RT

VIA AV:

1 A one way security surcharge of USD 5 will be assessed for any fare paying passenger each time travel involves enplanement on a AV flight between the USA and South America. For passengers travelling on a round trip, circle trip or open jaw journey via AV in both directions, the security surcharge will be assessed twice.

This surcharge applies in addition to all other charges and is not subject to any discount.

When a security surcharge is collected it must be denoted as a Q charge on each ticket accordingly. 2 If ticket is purchased in the USA for travel between the USA and South America, the security surcharge outlined above shall apply.

NOTE: For travel originating in South America, the security surcharge will be collected manually at the airport of point of turnaround.

3 Applicable for travel originating in Panama for travel to Colombia

A security surcharge of USD 5 OW or USD 10 RT for passengers enplaning AV flights from Panama to Colombia. This surcharge will be applied in addition to all other charges and is not subject to any discount. When a security surcharge is collected it must be denoted as a Q charge on each ticket accordingly.

via CM: Between Puerto Rico and TC1: USD 5 OW /USD10 RT

VIA CO:

1 CO will assess a security surcharge for any fare paying passenger each time travel involves enplanement on a CO international flight as specified below. The security surcharge will not apply to passengers who are travelling on any CO free ticket.

2 From USA to

- Caribbean except Bahamas: USD 7.50 OW/15 RT

- Central America / South America / Mexico: USD 5 OW / 10 RT

3 From USA except Key West / Ft Lauderdale / Ft Myers / Jacksonville / Miami / Orlando / W Palm Beach / Tallahassee / Tampa to Bahamas: USD 7.50 OW / 15 RT

4 From Key West / Ft Lauderdale / Ft Myers / Jacksonville / Miami / Orlando / W Palm Beach / Tallahassee / Tampa to Bahamas: USD 5 OW / 10 RT

5 From Caribbean exc. Bahamas / Dominican Rep. to USA: USD 7.50 OW / 15 RT

6 From Bahamas to

- USA except Key West / Ft Lauderdale / Ft Myers / Jacksonville / Miami / Orlando / W Palm



Beach / Tallahassee / Tampa: USD 7.50 OW / 15 RT

- Key West / Ft Lauderdale / Ft Myers / Jacksonville / Miami / Orlando / W Palm Beach / Tallahassee / Tampa: USD 5 OW / 10 RT

7 From Central America except Belize to USA: USD 5 OW / 10 RT

- 8 From Mexico / Caribbean / Central America except Belize: USD 5 OW / 10 RT
- 9 From Canada to Mexico / Caribbean / Central America / South America: CAD 7 OW / 14 RT

10 From St. Maarten to USA: additional USD 1.55

VIA JM:

JM will assess a security charge, for all fare paying passengers. This security charge will apply on all JM routes involving enplanement.

The charge is to be applied on all fares, and is in addition to all other charges. The security charge is not subject to any discount.

The surcharge is to be shown in the fare ladder of the ticket as Q.

1 between USA and the Caribbean / Panama: USD 7.50 OW / USD 15 RT

2 from Jamaica to Canada: USD 7 / CAD 12

3 within the Caribbean and between the Caribbean and Panama: USD 7.50 OW / USD 15 RT

EXCEPTION: from Jamaica to Antigua, Barbados, Bonaire, Curacao, Dominica, Grenada, St. Lucia, St. Vincent, Port of Spain, Tobago: USD 7.50 OW

VIA KX:

A one way security surcharge will be assessed for any fare paying passenger each time travel involves enplanement on a KX international flight specified below. For travel on a round trip, circle trip or open jaw journey via KX in both directions, the security surcharge will be assessed twice. This surcharge applies in addition to all other charges and is not subject to any discount.

1 Between USA/Canada and Cayman Islands: USD 7.50 / CAD 11.00 OW; RT double

2 Between Jamaica and Cayman Islands: USD 7.50 OW; RT double

3 Between USA and Jamaica: USD 7.50 OW; RT double

4 From Cayman islands to Barbados, Dominica, Grenada, St. Lucia, St. Vincent, Trinidad: USD 7.50 OW EXCEPTION: The security surcharge will not apply to passengers who are travelling on any KX free tickets.

via PZ: From USA to Area 1: USD 7.55 OW (Note 1) via TR: From USA to Brazil: USD 5 OW / 10 RT/CT/ OJ (Notes 1, 2)

VIA UP:

1 Applicable between USA and Bahamas A security surcharge of USD 5 per direction will be added to the applicable fare. The surcharge applies per enplanement and must be denoted in the fare construction ladder of the ticket as a Q surcharge. A surcharge of U 10 per direction will be added to the applicable fare for travel.

2 Applicable between Bahamas and Providenciales, Turks and Caicos A security surcharge of USD 3 per direction will be added to the applicable fare. The surcharge applies per enplanement and must be denoted in the fare construction ladder of the ticket as a Q surcharge. A surcharge of U 10 per direction will be added to the applicable fare for travel.



3 Applicable between Bahamas and International points in the Caribbean (except Providenciales, Turks and Caicos)

A security surcharge of USD 3 per direction will be added to the applicable fare. The surcharge applies per enplanement and must be denoted in the fare construction ladder of the ticket as a Q surcharge.

VIA US:

1 Between USA/Canada and

- Bahamas: USD/CAD 2/3 OW / 4/6 RT
- Bermuda, Netherlands Antilles, Jamaica, Mexico: USD/CAD 5/6 OW / 10/12 RT
- Cayman Islands: USD/CAD 7.50/9.50 OW; double RT
- 2 Between USA and
 - Areas 2/3 via AT / PA: USD 5 OW /10 RT/CT/ OJ (Note 1) or local currency equivalent at IROE

EXCEPTIONS: No security surcharge

- From CLT/PHL to LON/FRA
- From Germany to USA/Canada
- From UK to USA/Canada

NOTES:

1 The security surcharge will not apply to passengers travelling on any free ticket.

2 No security surcharge will apply for tickets / PT As sold/issued in Brazil.

3 The security service charge will not apply to:

- Infants.

- Passengers transferring / transitting Hong Kong SAR.
- Passengers travelling on Industry / Agency Discount (ID/AD) tickets.
- Passengers holding diplomatic passports.
- The surcharges apply in addition to all other charges and are not subject to any discount.

Surcharge to be shown as a 'Q' surcharge in the Fare calculation' box of the ticket, converted info NUCs at IATA Rate of Exchange (IROE).
